Henrieta Scholtzová is a Research Assistant Professor in the Department of Neurology and the Center for Cognitive Neurology at NYU. She earned her MD and PhD degrees from the University of P.J. Šafárik, Košice. Henrieta's PhD and post-doctoral studies were performed in the Conformational Disorders Laboratory at NYU, where she worked extensively on designing novel immunotherapeutic ap-

proaches for Alzheimer's disease (AD) and prion diseases. Her current research is focused on reducing age-related defects in immune cell function and lowering AD pathology via stimulation of the innate immunity using AD mouse models and squirrel monkeys. She recently received an Alzheimer's Association Research Grant Award to further validate this treatment strategy, laying the foundation for future clinical testing. In addition, she has been engaged in outreach activities through the Neuroscience Outreach Group at NYU during Brain Awareness Weeks and in establishing a PhD student exchange program between Slovak Universities and NYU.
